PROVIDER GRANT PROGRAM

Leech Lake Child Care Services manages two grant programs, local & statewide.

LOCAL GRANTS PROGRAM

- Funding for this service comes through the Federal Administration for Children & Families.
- The purpose of this funding is to increase the quality of care for Native American children within the Leech Lake Reservation service area.
- To be eligible, a provider must currently care for Native American children.
- Two grant rounds are offered - one in the Spring and one in the Fall.
- The local grant program is managed by Becky Littlewolf, Child Care Services Program Manager. She can be reached at (218) 335-8257 if you have any questions or concerns.

STATEWIDE GRANTS PROGRAM:

Funding for this service comes through the MN Department of Human Services.

- The purpose of this funding is to increase the quality of care for children who are cared for by Native American child care providers throughout the state of Minnesota.
- To be eligible for family child care grants, a provider must be licensed by a tribal government or be an enrolled member of a federally recognized tribe or be a first or second generation descendent of an enrolled member.
- To be eligible for center based grants, the facility must be licensed by a tribal government, funded by a tribal government or provide services predominantly for Native American children.
- The statewide grants program is managed by Sandra Williams, Program Manager for Minnesota Tribal Resources for Early Childhood Care (MN TRECC). She can be reached at (218) 335-8381 if you have any questions or concerns.

REGIONAL GRANT SERVICES:

All child care providers are eligible to apply for regional child care grants through the District Child Care Resource & Referral (CCR&R) Agency

LICENSED CHILD CARE PROVIDER

ESTIMATED INCOME W/ FOOD PROGRAM

ONLY LICENSED CHILD CARE PROVIDERS ARE ELIGIBLE
FOR THE CHILD CARE FOOD PROGRAM

WEEKLY—4 kids @ \$2.50 x 45 hours = \$450

MONTHLY—4 kids @ \$2.50 x 180 hours = \$1,800

YEARLY—4 kids @ \$2.50 x 2160 hours = \$21,600

(CCFP yearly reimbursement = \$3,931)

YEARLY TOTAL = \$25,500

WEEKLY—6 kids @ \$2.50 x 45 hours = \$675

MONTHLY—6 kids @ \$2.50 x 180 hours = \$2,700

YEARLY—6 kids @ \$2.50 x 2160 hours = \$32,400

(CCFP yearly reimbursement = \$5896.80)

YEARLY TOTAL = \$38,300

WEEKLY—8 kids @ \$2.50 x 45 hours = \$900

MONTHLY—8 kids @ \$2.50 x 180 hours = \$3,600

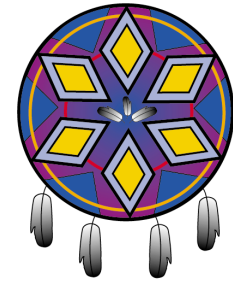
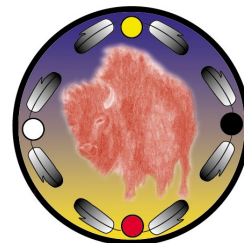
YEARLY—8 kids @ \$2.50 x 2160 hours = \$43,200

(CCFP yearly reimbursement = \$7,862.40)

YEARLY TOTAL = \$51,000

- Care for as many or as few children as you want. *(within guidelines)*
- **Be your own boss—set your own hours.**
- Claim tax deductions for the business use of your home.
- Receive referrals from our agency when parents are looking for child care.
- Have access to professional support and networking with other licensed providers.
